There is no D&AR/Vig./SPE case pending against Shri Hirdesh Kumar as per DRM(P)/NR/NDLI's letter No.941-E/603/Pl.VIP-4 dated 24.06.2020. He may exercise option for fixation of pay as AEN in Group 'B'/Civil Engg Service within one month from the date of his promotion in terms of CPO's Estt. Serial No.231/B1 and as per extent rules.

(ii) He has reported to this office on completion of 14 days home quarantine on 13.07.2020 (FN). Hence, the period from 13.07.2020 to 20.07.2020 will be treated as "waiting for orders" in his favour.
