


- The eligibility letter may be given wide publicity and may be intimated to the staff concerned under acknowledgement. In case of the candidate is in leave or sick, he may be intimated at his leave/sick address regarding this notification and the copy of the acknowledgement may be sent to this office for record within 07 days of issue of this eligibility letter.
- The above staff may be alerted to be in readiness to appear at the written examination which will be held at short notice.**
- The eligible candidate should note that their candidature is provisionally accepted and in case any discrepancies/deficiency is found later, his candidature is liable to be cancelled.
- There will be no supplementary examination for the absentee, as this is a general selection. Syllabus has already been circulated vide this office notification under reference above dt.24.02.2020.
- Representation if any may be submitted to this office within 15 days from the date of issue of this letter.

- If the staff prefers to write the examination in Hindi he may intimate in writing to this office through his controlling officer within 10 days of issue of this letter otherwise it will be presumed that he will write the examination in **ENGLISH**.
