- 1.0 By utilizing the powers delegated by Board's in terms of letter referred at (i) above, Northern Railway has forwarded a proposal with due approval of the General Manager to include following routes in the list of already identified CC+8 routes:

5		Firozpur Cantt-Jalandhar City (FZR-JUC)
6		Lohian Khas-Phillaur (LNK-PHR)
7		Bathinda-Kotakapura-Firozpur Cantt (BTI-KKP-FZR)
