Sub: Restriction of Parcel traffic over Delhi area in connection with

Independence Day.

Ref: CCM (FM)/Northern Railway's letter No. 36-RD/982/Restriction/Parcel/Pt-II

dated 07.08.2020.

An extract of the CCM(FM)/Northern Railway's letter No. 36-RD/982/Restriction/Parcel/Pt-II dated 07.08.2020 is reproduced below for information & necessary action:-

"Keeping in view of security arrangement during Independence Day celebrations, restriction is hereby imposed on all types of Parcels transactions (including lease) in Delhi area (NDLS, DLI, HNZM, ANVT, DEE and ANDI) on 12<sup>th</sup>, 13<sup>th</sup>, 14<sup>th</sup> and 15<sup>th</sup> August -2020. Parcel Godowns and platforms shall remain free of parcel packages/packings. In the wake of Special arrangements this year, restriction is imposed on both inward and outward traffic including leased SLR, AGC & VPs at all the aforesaid stations.

The personal luggage may be allowed in the passenger coach only and booking of registered newspapers and magazines shall be permitted after observing all commercial formalities.

This restriction is applicable on leased SLR, AGC and VPs of the trains originating from Delhi area stations (i.e NDLS, DLI, HNZM, ANVT, DEE and ANDI) and also applicable for passing trains originating from other divisions / zones and having stoppages in Delhi area for loading /unloading."

All concerned to note and act accordingly.
