- 1.0 In terms of Rates Circular No.16 of 2019 dated 02.08.2019, the Hire Charges on Wagons interchanged were notified and revised from 06.08.2019.
- 2.0 The matter has been reviewed and sanction of the Competent Authority is hereby accorded to effect the enhancement of Hire Charges on Wagons interchanged as follows:

a) Hire charges for Inter-Railway Financial adjustment:

- 3.0 These Rates shall apply on other types of wagons according to their equation in terms of 8 wheelers.
- 4.0 These rates shall apply to all Port Trust Railways.
- 5.0 These rates shall come into force w.e.f. 01.09.2020 and shall remain valid till 31.08.2021.
- 6.0 This issues in consultation with Stat Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
