In terms of Railway Board's letter No. PC-V/2009/ACP/2 dtd. 10.06.2009 the following staff working under PFA/ECOR is granted financial up-gradation under MACPS-09, as detailed below:-

The above financial up-gradation under MACPS-2009 is subject to following conditions:-

1. There will be no change in the designation or the nature of duty being performed. The status of the employee remain unchanged.
2. The financial up-gradation under MACP Scheme is purely personal to him and shall have no relevance for his seniority position i.e., this will not confer on him any seniority benefit. **This will be ceased from the date of regular promotion.**
3. Grant of higher grade pay under the MACP Scheme shall be conditional to the fact that the employee concerned while accepting the said benefits shall be deemed to have given his unqualified acceptance for regular promotions on occurrence of vacancy subsequently.
4. The employee getting FUG under MACP may exercise option whether he want his pay to be fixed from the date of accrual of next lower grade increments, in terms of this office order. Any option received after one month will not be entertained under any circumstances. He is also advised that the option once exercised shall be final.
5. Any modifications/clarifications follows latter on to the basic MACPS'2009 Circular shall be binding on the employee benefited vide this Order and the necessary financial implications what so ever would be re-assessed and would be modified further if warranted by such modifications /clarifications.
6. The financial up-gradation entitles the employee concerned to avail advances, loans, Passes and PTOs, TA and higher type of quarter's accommodation etc. which are based on the pay drawn without conferring any privilege relating to higher status.

The above up-gradation has the approval of Competent Authority.
