Commercial Circular No. 211(G) / 2020

Sub: Revision of chargeable distance for the Private siding of M/s. Vedanta Limited (MAVB) served by Brundamal station.

Chargeable distance for the private siding of M/s. Vedanta Limited, Brundamal (Alpha Code - MAVB & Numerical Code - 12221468), was last revised vide Commercial Circular No. 52(G)/2017 dated 31.03.2017.

Consequent upon clarification issued by Railway Board pertaining to 'Y' connections to private sidings, the chargeable distance of MAVB siding has been reviewed and revised as **Brundamal (BXQ) + 7.76 Km (Seven decimal seven six Km)**.

However, any freight already collected due to inflation of chargeable distance by five kilometers for 'Y' connections before issue of this notification shall not be considered for adjustment/reimbursement.

The above instructions shall come into force **with effect from 11.09.2020**.

All concerned to note and act accordingly.


