PART -A

- The above named promotee is to report to the Controlling Officer within seven days from the date of issue of order, failing which it will be deemed that he/she is unwilling to accept the promotion and in that case he/she will be debarred from promotion for a period of one year from the date of issue of this order.
- No Transfer privileges are admissible in respect of Sr.SO at Srl.No.1 of Part-A, since his transfer is arranged on basis of 'own request'.
