

The proposal sent vide letter under reference and subject above has been examined. In terms of Para 7.1 of the CPLP (FM Circular No. 05/2016), provision for temporary leasing of SLRs already exists. However, the same is not permitted for Parcel Vans.

The matter has been deliberated upon, and it has been decided that with a view to maximize Railway earnings, temporary leasing of Parcel Vans to be attached to Passenger Special Trains shall also be allowed for 30 days at a time, on quotation basis. However, Reserve Price for the same shall be decided in consultation with Associate Finance.

This issues with the concurrence of Finance Directorate of Railway Board.

This has the approval of Competent Authority.




