

Sub: Clarifications on 'Advance Booking of Parcel space' and 'Temporary Leasing of Parcel Vans.'

Ref: (i) Board's letter of even number dated 11.09.2020.
(ii) Board's letter No. 2020/TC(FM)/10/13, dated 18.09.2020.

Attention is invited to the Board's letter under reference (i), wherein advance booking of parcel space in SLRs & VPs to be attached to Passenger-carrying trains, and time-tabled Parcel Special Trains, was permitted 120 days in advance.


Vide Board's letter under reference (ii), temporary leasing of Parcel Vans to be attached to Passenger Special Trains has been permitted for 30 days at a time, on quotation basis.

During the Video Conference with PCOMs and PCCMs held on 20.09.2020, chaired by the Member/O&BD, Zonal Railways requested for more clarity on these instructions.

It is therefore, clarified that:

1. The advance booking of Parcel space, as stipulated in the letter dated 11.09.2020, may be train specific.
2. Both the schemes, i.e. advance booking of Parcel space, and temporary leasing of Parcel Vans on quotation basis, shall remain operational.
3. For temporary leasing of Parcel Vans, all the relevant provisions of the Comprehensive Parcel Leasing Policy (such as leasing of Parcel Vans on round trip basis, open only for registered lease holders, etc.) shall be applicable.
4. Railways may go for temporary lease only for trains/period where there are no takers for advance booking.
