A notification was circulated vide this office letter under reference for filling up of 02 (Two) vacancies of Publicity Inspector i.e. UR-02, SC-00 & ST-00 against departmental promotion quota (DPQ).

In response to this office letters dated-19.03.2020, 23.04.2020 & 11.06.2020, total 18 (Eighteen) applications were received. On scrutiny of the applications, 05 (Five) applications are found eligible provisionally to appear at the selection process and 13 (Thirteen) applications are found ineligible due to various reasons mentioned against their names in Annexure-II. The eligible and ineligible lists of applicants are enclosed as Annexure-I & Annexure-II respectively which should be made wide publicity amongst the staff concerned. The eligible candidates may be advised to be ready for the written exam which will be held at short notice.

Eligible candidates should note their candidature is provisionally accepted and in case any discrepancies/deficiency is found later, their candidature is liable to be cancelled.

There will be no supplementary examination for the absentees, as this is a general selection. Syllabus has already be circulated vide this office letter dated-19.03.2020.
