Sub: **Forfeiture of Wagon Registration Fee – Iron Ore**
Ref: Chapter II of Goods Tariff

Please refer to rule 201(15) of Goods Tariff regarding forfeiture of Wagon Registration Fee.

The matter has been examined and it has been decided to revise the circumstance for forfeiture of Wagon Registration Fee (WRF) in the case of Iron Ore by modifying rule 201(15)(a) of Chapter II of Goods Tariff, as under:

EXISTING RULES	REVISED RULES
Forfeiture of Registration Fee – Registration fee will be forfeited under any of the following circumstances :- (a) When the wagon indent is cancelled after physical supply of the wagon.	Forfeiture of Registration Fee – Registration fee will be forfeited under any of the following circumstances :- (a)When the wagon indent is cancelled after physical supply of the wagon. However, in case of Iron Ore, Wagon Registration Fee will be forfeited if indent is cancelled after allotment of rake in Rake Allotment System (RAS). All other instructions will continue to apply unchanged.

These instructions will be implemented with effect from 10.10.2020.

This issues in consultation with Traffic Transportation directorate and with the concurrence of Finance directorate of Ministry of Railways.
