**Sub:** Additional free time for covering Open wagons with tarpaulins at EOL siding.

**Ref:** Rates Master Circular /Demurrage-Wharfage-Waiver/2016/0 and amendments thereto, circulated vide CCM/ECOR's Commercial Circular No.65(G)/2016 dated 20.05.2016 and amendments thereto.

Reference has been received regarding additional free time for covering open wagons (carrying loose / bulk consignment) with tarpaulins at EOL sidings.

The matter has been examined and it has been decided that additional free time of one hour per rake may be permitted for covering open wagons with tarpaulins during loading of loose / bulk commodity (e.g. Coal & Coke etc, for which packing condition P2 (a) is prescribed in the Goods Tariff) at EOL sidings, by inserting Para 2.5.1 of Chapter-I of Rates Master Circular under reference, as under:-

**"2.5.1 Additional free time for covering Open Wagons with tarpaulins at EOL sidings**

Additional free time of one hour per rake may be permitted for covering open wagons with tarpaulins during loading of loose / bulk commodity (e.g. Coal & Coke etc, for which packing condition P2 (a) is prescribed in the Goods Tariff) at EOL sidings."

This issues in consultation with Traffic Transportation directorate and with the concurrence of Finance Directorate on Ministry of Railways.

All concerned to note and act accordingly.


