- 1.0 By utilizing the powers delegated by Board's in terms of letter referred at (i) above, South Western Railway has forwarded proposal with due approval of the General Manager to include following route in the list of already identified CC+8 routes:

| 1.    | South Western Railway | Kadur (DRU) – Chikmagalur (CMGR)       |
| 2.    |                       | Arsikere (ASK) – Hassan (HAS)          |
| 3.    |                       | Hassan (HAS) – Mysuru (MYS)            |
| 4.    |                       | Baiyyappanahalli (BYPL) – Omalur (OML) |
| 5.    |                       | Kengeri (KGI) – Mysuru (MYS)           |

- 2.0 Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed. Now, sanction of the Competent Authority is hereby accorded to include above referred route of South Western Railway in the list of already identified CC+8 routes.
- 3.0 All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
- 4.0 These instructions shall come into effect from 11.10.2020 and shall remain valid till further advice.
- 5.0 The Rates Master Circular under reference accordingly be modified.
