Sub : Approval for two point loading for (i) 3 rakes of BFNS, (ii) 4 rakes of BFNSM+2BFNS and (iii) 2 rakes of BFNSM + 1 rake of BFNS procured by M/s TMILL under SFTO.

Approval of Ministry of Railways (Railway Board) was communicated for procurement of 6 BFNSM and 6 BFNS 22.9T rakes under Special Freight Terminal Operator Scheme (SFTO) vide Board's letters under Reference (ii) above. Additional originating and destination stations for these rakes were also granted.

2. M/s TMILL has sought permission for two point loading for these rakes in terms of FM Circular No. 11 of 2020 (ref-iii). The matter has been examined in this office and approval for two-point loading is granted in the following circuits:

2.1 For 3 BFNS rakes (**approval granted on 20.07.16**) and for 4 BFNSM and 2 BFNS rakes (**approval granted on 27.09.18**), following points (via per RBS routes) are approved:
