Commercial Circular No.275(G)/2020

Sub: Classification of Petroleum Coke-Segregation from Main Commodity Head "Coal and Coke".

Ref: IRCA Goods Tariff No.49 Pt.I Vol.II.

1.0 IRCA Goods Tariff No.49 Pt.I Vol.II contains General Classification of goods. The classification of the commodities have been given in the Goods Tariff under Main Commodity Head / Sub-head and three Divisions of Low Rated Commodities. Main Commodity Head "Coal and Coke" is listed at Group No.8 at Page No.12 of Goods Tariff with Classification of Class-145A. Different types of Coal and Cokes are placed in this group.

2.0 The commodities listed under Main Commodity Head "Coal and Coke" have been reviewed. Sanction of Competent Authority is hereby accorded to segregate the Petroleum Coke and its variant from this commodity group and list them in a separate commodity Group No.8B under a separate **Main Commodity Head "Petroleum Coke"** below commodity group No.8.

3.0 Accordingly, the commodities viz. Petroleum Coke, Raw Petroleum Coke and Calcined Petroleum Coke appearing in Commodity Group No.8 may be taken out from this group and placed at new Group No.8.1 in **Main Commodity Head "Petroleum Coke"** as per the following:

Existing sub-commodities under Coal & Coke group, except those brought under 8.1 above, shall continue to be under 8.2. The charging of commodities under Main Commodity Head "Petroleum Coke" will continue to be done at par with the commodities under Main Commodity Head "Coal and Coke".

4.0 It has also been decided that the commodities under Main Commodity Head "Petroleum Coke" will eligible for discount/concession under Station to Station Rate (STS) Scheme contained in Rates Circular No.26 of 2016 {Circulated vide Commercial Circular No.133(G)/2016 dated 30.09.2016} amended from time to time. Further, the exclusion and inclusion applicable on head 8.2: "Coal and Coke" with respect to all other freight incentive schemes / policies shall continue to be applicable on head 8.1: "Petroleum Coke", unless otherwise specified in any policy.

5.0 The above instructions shall come into force w.e.f. 16.10.2020 and shall remain in force till 15.10.2021.

6.0 This issues with the concurrence of Finance Directorate in the Ministry of Railways.


