



A notification was circulated vide this office letter under reference for filling up of Chief Protocol Inspector in Level-07 & Protocol Inspector in Level-06 on ex-cadre basis in General Administrative Department/HQ/BBS.

In response to this office notification dated-28.07.2020, total 36 (Thirty Six) applications for Chief Protocol Inspector and 28 (Twenty Eight) applications for Protocol Inspector have been received by this office. On scrutiny of the applications, 33 (Thirty Three) applications for Chief Protocol Inspector and 28 (Twenty Eight) applications for Protocol Inspector are found eligible provisionally to appear the selection process and rest 03 (Three) applications for Chief Protocol Inspector are found ineligible due to various reasons mentioned against their names.
