Reference has been received from Defense authority seeking certain relaxation in the Tariff applicable in case of Military Traffic.

The matter has been examined and it has been decided to permit relaxation in charging of Coaching Trains and Mixed trains (coaching+goods) by modifying following paras of Rates Circular No.32 of 2014, as given below-

Para	Existing Guidelines	Revised Guidelines
2.4		Charge for coaching train shall be levied for actual number of coaches in the train subject to a minimum charge for 10 coaches per train.  This relaxation will be applicable till 31.03.2021 and post which, the charge for coaching train shall be levied for actual number of coaches in the train subject to a minimum charge for 18
3.3	worked out for actual number of	Total charge for mixed train should be worked out for actual number of coaches/wagons used subject to minimum charge for 30 bogie wagons (including a minimum of one coach).  This relaxation will remain valid till further advice.

All other extant guidelines will remain unchanged.

This issues in consultation with Mechanical and Traffic Transportation directorates and with the concurrence of Finance directorate of Ministry of Railways.
