Commercial Circular No. 282(GC)/Parcel/2020

Sub: Haulage charge recoverable for movement of Milk traffic in Railway Milk Tankers (RMT) owned by private parties.

Ref: Railway Board's letter No.TC-II/2642/2020/Milk-Policy dated.29.09.2020 (Freight Marketing Circular No.17 of 2020)

Extract from Railway Board's letter under reference is reproduced below:

- On the request of Milk producers/transporters, in order to promote milk traffic, Ministry of Railways have decided - as a special case- not to increase the Haulage Charges for movement of Milk traffic for the period from 01.07.2020 to 30.06.2021. Also, no increase was made in Haulage Charges for movement of Milk traffic for the period 01.07.19 to 30.06.2020.
- Accordingly, the Haulage Charges for movement of Milk traffic for the period from 01.07.2020 to 30.06.2021 shall remain the same as per the Haulage Charges applicable for the period 01.07.18 to 30.06.2019, notified vide FM Circular No.07 of 2018 dated 14.03.2018.
- 3. Haulage Charges for new Rail Milk Tankers (VVNH1) shall continue to be calculated by multiplying a factor @1.12 times of the applicable Haulage Charges, as per FM Circular No.23 of 2019 dated 11.09.2019.
- 4. No charges are to be levied for empty movements of RMTs from unloading points to the loading points for re-loading.
- 5. There shall be no change in other terms and conditions.
