**Sub: Grant of train load benefit during slack season.**

A doubt has arisen on some railways as to whether the approved trainload combination circulated vide Board's letter no. 2003/TT-IV/9/3/Rake list Jumbo dated 4.11.2003 for the full year is valid for loading during the slack season in BCN stock. The matter has been examined in Board's office in consultation with Traffic Transportation directorate. It is clarified that the approved two point combination for which train load benefit is granted for the full year would also be applicable for granting train load benefit in the slack season. The list of combination notified in Board's letter no. 2003/TT-IV/9/3/Rake list Jumbo dated 4.11.2003 for the slack season is in addition to the combinations listed for the full year. However the use of BCN stock to load to these two point combinations is limited to the slack season only which has been defined in the above mentioned circular as period from May to October.

This issues with the approval of Finance Directorate in the Ministry of Railways.
