
For conducting the viva-voce test, the APARs for the years 2014-15, 2015-16, 2016-17, 2017-18 & 2018-19, Service Book, Personal File, D&A clearance and original Medical fitness certificate of prescribed standard for the post of AEN/Group-B of Sri V.A.D. Somalingam should be sent to PCPO/BBS on or before **20.11.2020** positively through special messenger.

In terms of Railway Board's letter No. E(GP)80/2/8 dtd. 31.10.91 only those candidates who qualify in the medical examination of prescribed standard should be advised to appear in the viva-voce test. Accordingly, the respective controlling officer/Personnel Officer should direct the above named written qualified candidate for medical fitness of prescribed standard for the post of AEE/Group-B before the viva-voce test.
