Sub: Preferential Traffic Order GO No.94 - Amendment No.2


Please refer Board's letter No. 2017/TT-III/1/1 dt.23.03.2020 circulating therewith a copy of preferential Traffic Order G.O. No.94 effective from 01.04.2020 (CCM/ECoR's Commercial Circular No.186(G)/2020 dt.06.08.2020). It has been now decided to revise Para 2.2 and add Para 2.3 of Preferential Traffic Order GO No.94 as under:

Existing Provision	Modified provision
Para 2.2 :- Food grains and levy sugar for public distribution system or other welfare schemes sponsored by Food corporation of India/State Government or their Agencies as per the list in Annexure-I and approved by Zonal Railways/Railway Board. Proposals for sponsorship of any other commodity by a Central Government Agency will require specific approval of Railway Board.	Para 2.2 : Food grains sponsored by Food corporation of India/State Government or their Agencies as per the list in Annexure-I and approved by Zonal Railways/Railway Board or Non- sponsored food grains except quota traffic advised by Railway Board. Para 2.3 :- Levy sugar for public distribution system or other welfare schemes sponsored by Food corporation of India/State Government or their Agencies as per the list in Annexure-I and approved by Zonal Railways/Railway Board. Proposals for sponsorship of any other commodity by a Central Government Agency will require specific approval of Railway Board.

The above amendment will come into force from 2nd Novemeber,2020.
