In terms of this office letter under reference, Board's decision on following items was conveyed for compliance:

- a. Freezing new posts creation except safety, till further orders;
- b. Reviewing of posts created in last two years and if, recruitment has not been done against these posts, reviewing the same for surrendering; and
- c. Surrendering 50% of existing vacancies, in other than Safety category.

2. In continuation to the above letter, it is advised that Zonal Railways in the meetings held with Railway Unions from time to time, v.i.z. PNM and other forums, should inform and discuss the action taken on para 1 above.
