Sub: Charging of automobile traffic when carried on BRN wagons.

Ref: Rates Circular No. 24 of 2019 dated 27.11.2019 and corrigendum thereto in continuation to Rates Circular No. 11 of 2018 and 22 of 2018.

1. Reference above, Board had notified charging for Automobile Traffic, when loaded in NMG, BCCNR, BCACM wagons.
2. It has been brought into the notice of the Board that there is great demand of transportation of automobile traffic, but railway is not in a position to supply NMG BCCNR, BCACM rakes.
3. The matter has been reviewed, and the Competent Authority have decided, as a special case, to allow to make use of BRN rakes in case there is great demand of transportation of automobile traffic, but railway is not in a position to supply NMG BCCNR, BCACM rakes, BRN can be allowed in empty flow direction only, if higher value freight is not available for loading. PCOM is empowered to take decision/procedure with respect to certifying the conditions.
4. Charging of Automobiles traffic on BRN rake shall be in terms of the indent made by the customer in accordance to above referred Rates Circulars i.e. if a customer has made an indent of 25 NMG wagons but railway is not in a position to supply NMG but supplied BRN, then charging shall be equivalent to 25 NMG wagons. However, if the full rake of BRN is loaded, charges for the full rake on a *pro rata* basis with respect to NMG shall be applied.
5. Rule of Standard Rake Size of BRN rake shall be relaxed in such case(s) i.e. if the automobile traffic offered against the indent of 25 NMG wagons can be adjusted in 20 BRN, then 20 BRN shall be loaded, however, the charging shall be as per para 4. above i.e. for 25 NMG wagons.
6. This instruction shall come into force w.e.f. 12.12.2020 and shall remain valid till 31.01.2021.




