Sub: Routes of running of 25 Tonne Axle load wagons.

- 1 In terms of reference at (i) & (ii) above, Board's approval communicated for restarting of 25 Tonne axle load operation with such rolling stock as are fit / certified for 25 Tonne axle load on various notified routes.
2. The routes are notified in terms of reference (iii) above.
3. Matter has been reviewed and the Competent Authority has approved to add following routes, in the list attached as Annexure-IV of Rates Master Circular under reference (iii) above as 25 Tonne axle load notified routes:

Railway	Name of Routes
SER	Gua – Bolanikhadan – Barajamda - Padapahar
SER	Damodar – Burnpur – Asansol / Kalipahari

4. Accordingly, Annexure - IV of Rates Master Circular under reference (iii) above shall be modified.
5. This issues in consultation with Traffic Transportation and Finance Directorate of Ministry of Railways.
