Addendum-01 to Freight Marketing Circular No.21 of 2020 (This office CC. No.273(GC)/Parcel/2020 dated 14.10.2020).

Sub: Discount on Base Freight Rate for Indented Parcel Trains consisting of LVPH (LHB Parcel Vans)


Ref: Railway Board's Freight Marketing Circular No. 21 of 2020 issued vide letter No. TC-II/2046/2020/Discount-On- P' scale dated 14.10.2020 (This office CC No. 273(GC)/Parcel/2020 dated 14.10.2020).

Extract from Railway Board's FM Circular No.27 of 2020 issued vide letter No. TC-II/2046/2020/Discount-On- P' scale dated 14.12.2020 is reproduced below for information & necessary action:-

- “Vide Freight Marketing Circular No. 21 of 2020, instructions were issued for grant of 8% discount on Base Freight Rate of P-scale on Indented Parcel Trains if twenty-four Parcel Vans plus Brake-van are indented for and loaded in a single Parcel trains.
2. In continuation of the same, Ministry of Railways have decided that in case of LVPH (LHB Parcel Vans), the discount of 8% on Base Freight of P-scale shall be granted if **twenty-three (23) Parcel Van plus Guard-van(s)** are 'indented for and loaded' in a single Parcel train.
 3. Other terms and conditions, as mentioned in Freight Marketing Circular No.21 of 2020 shall remain applicable.
 4. This issues in consultation with Coaching Directorate and with the concurrence of Finance Directorate of Ministry of Railways.”

All concerned to note and act accordingly.
