- 1.0 By utilizing the powers delegated by Board's in terms of letter referred at (i) above, Western Railway has forwarded proposal with due approval of General Manager to include following route in the list of already identified CC+8 routes:

- 2.0 Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed. Now, sanction of the Competent Authority is hereby accorded to include above referred route of Western Railway in the list of already identified CC+8 routes.

- 4.0 These instructions shall come into effect from **31.12.2020** and shall remain valid till further advice.


