**Sub: Haulage Charge for movement of Zinc Concentrate, Lead Concentrate and Soap Stone Powder in containers**

Please refer to Railway Board's letter No. 2020/TT-III/73/21 dt 14.12.2020 (container train Circular No.03/2020) (this office Commercial Circular No. 359(G)/2020) vide which it has been decided to permit loading of 'Zinc Concentrate, Lead Concentrate and Soap Stone Powder' in containers.

Competent Authority has now decided that Zinc Concentrate, Lead Concentrate and Soap Stone Powder when transported in containers shall be charged at Container Class Rate i.e. by applying 15% concession on applicable class rate as published in IRCA Goods Tariff No.49 Pt-I Vol-II and as amended from time to time.

This issues in consultation with Traffic Transportation Dte. and with the concurrence of Finance Dte. of Ministry of Railways.

All concerned to note and act accordingly.


