

6. If the tender opening day is declared to be a holiday or remain closed due to some unforeseen circumstances the tender quotations will be opened on next working day.

The Successful Tenderer shall submit Bank Guarantee/FDR to the amount equivalent to 5% of annual contractual value as per lumpsum leased freight (accepted Rates) of the leased parcel space or Rs.4,00,000/- (Rupees Four lakh) which ever is higher as Security Deposit. However, the EMD if so desired by the Lease holder will be converted as Security Deposit.
8. The Successful Tenderer shall pay the Lumpsum Leased freight one day in advance from the nominated day of loading.
