

Ministry of Railways, with the approval of competent authority, have now decided to further extend the engagement of Medical Practitioners over and above the vacancies in Indian Railway Health Service (IRHS) to meet the local requirements for handling the COVID - 19 pandemic from 01.01.2021 to 30.06.2021 or till the pandemic of COVID-19 continues, whichever is earlier, with the same terms as contained in Board's letters cited above. It may please be noted that this is purely a temporary measure, after which status quo ante will be restored.
