

EMPLOYMENT NOTICE NO.01/2021- CMP

**ENGAGEMENT OF CONTRACT MEDICAL PRACTITIONER**

In view of the exigencies related with the COVID-19 global pandemic and in view of adequate preparedness, it has been decided to engage one Contract Medical Practitioners (CMP) on temporary basis for a period of from the date of joining to 30.06.2021 or till the pandemic COVID-19 continues, whichever is earlier of such engagement in Sambalpur, East Coast Railway from willing & eligible Doctors, which can be extended purely on administrative requirement. The details of the scheme are given below:-

**TOTAL NO OF REQUIREMENT - 01 Nos. (CMP)**

Since the posts are over and above the sanctioned posts due to the exigencies on temporary measure, no prescribed community distribution (SC/ST/OBC) is applicable.

- N.B.
1. THE REQUIREMENT MAY ALTER AS PER ADMINISTRATIVE REQUIREMENT AT ANY TIME DURING THE ENGAGEMENT.
  2. ADMINISTRATION RESERVES THE RIGHT TO PLACE THE ENGAGED CMPS ANYWHERE IN THE JURISDICTION OF SAMBALPUR DIVISION IN THE QUARANTINE FACILITY & ISOLATION WARD.
  3. RETIRED RAILWAY DOCTORS, RETIRED GOVERNMENT MEDICAL DOCTORS OF STATE GOVERNMENT AND CENTRAL GOVERNMENT WHO ARE PHYSICALLY FIT UPTO 65 YEARS OF AGE ARE ALSO ELIGIBLE.

**EDUCATIONAL QUALIFICATION/ELIGIBILITY :**

The candidate should be a minimum MBBS pass degree from an institute recognized by the Indian Medical Council and with registration in Indian Medical Council, or with a valid registration certificate of any of the State Medical Councils of India after completion of one year of compulsory, rotatory Internship. No other certificates will be accepted. Higher qualification, if any or Retired Railway Doctors will be given due preference.

- AGE** (i) Not exceeding 53 years of age as on 01.02.2021. However, age relaxation is admissible for 5 years for SC/ST category candidates and 3 years for OBC category candidates.  
(ii) For retired Railway Doctor, retired Government Medical Doctors of State Governments and Central Government, age to be considered is 65 years as on 01.02.2021.

**REMUNERATION :**

- a. Monthly remuneration is ₹ 75,000/-(including HRA & Transport Allowance) for Full Time General Duty Medical Officer (GDMO).
- b. For retired Railway Doctors, retired Government Medical Doctors of State Government and Central Government, the monthly remuneration, as decided by Railway Board, is subject to the condition of retirement. No Dearness and any other allowances which are admissible to regular Railway Servants shall be admissible.
- c. In case a railway accommodation is provided to the CMP, an amount equivalent to license fees in normal rent of the accommodation so provided shall be deducted from the monthly fees admissible.

**MODE OF SELECTION:-**

Eligible and willing candidates will send the scanned copy of their application in the prescribed format along with scanned copies of their Certificates/Work Experience Certificates (if any)/Testimonials on mail id [cms\\_sbp@sbp.railnet.gov.in](mailto:cms_sbp@sbp.railnet.gov.in). on or before 10.02.2021. After scrutiny of the application, interview through video conferencing would be taken of eligible candidates for which they would be intimated through their e-mail & whatsapp number. Selected candidate will be intimated through the whatsapp number/ Email Id of the candidate. While reporting for duty, the candidate will be required to bring all the original Certificates/Testimonials for verification and two passport size photographs. After due verification of the Certificates/Testimonials, the final engagement order will be issued





**OTHER TERMS AND CONDITIONS :**

- i. Selected candidates will be subjected to medical examination and only medically fit candidates will be engaged as CMP.
- ii. The Contract Medical Practitioner who enters contract with Railways will not have any claim or right for his/her continuity or automatic extension of the term of contract.
- iii. During the validity of the contract, the CMP will be at liberty to terminate the contract for betterment of his/her career or any other ground by giving 15 days prior notice to the Railways. The contract can also be terminated by the Railways at any time during the contract by giving 15 days notice without assigning any reasons whatsoever. The contract shall also be terminated by the Railways administration if the CMP is found to be mentally or physically incapacitated
- iv. Engagement as CMP will not confer any right for automatic regularization or absorption in railways.
- v. The CMP may avail of free medical treatment for self only except operations categorized as 'special' in para 622(8) of IRMM 2000 and treatment normally available at super specialty centre from his/her respective zonal railway hospitals during the period of contract.
- vi. The detailed instructions with regard to the duties while in contract in Railways shall be given to CMP concerned in the event of selection along with the offer of engagement.
- vii. The administration of the ECoR/Sambalpur division reserves absolute right to cancel this notification without assigning any reason(s).
- viii. No Railway privilege passes/PTOs shall be admissible to Retired Railway Doctors engaged as CMP in his/her capacity of CMP. However, 'Duty passes', as per eligibility would be provided for outstation duties to the CMPs.


