

1.0. In terms of Annexure-I to Rates Master Circular under reference at (i) above, list of wagons fit for 25 tonne axle load route has been prescribed. The matter has been reviewed and now the Competent Authority has decided to include BOXNHL25T wagons in the list of already notified wagons fit for running on 25 tonne axle load routes with specifications as under:

Permissible Carrying Capacity (in tonnes) of wagon on 25 Tonne Axle load Route

| BOXNHL25T | 78.4 | As on CC+8 routes | 1 |

##When wagons other than BOXNEL, BOBSNM1, BOYEL, BOBSN and BOXNHL25T move on 25 tonne axle load routes, PCC for those wagons will be same as that applicable on CC+8 routes.

Standard Rake Size of BOXNHL25T wagon shall be 58 wagons and Minimum number of wagons to be loaded shall be 57 wagons. (refer Annexure I to Rates Master Circular on Block Rakes/Mini Rake/Two Point Combination etc./2020)

- 2.0 Accordingly, Annexure-I of Rates Master Circular under reference (i) and reference (ii) above shall be modified.
- 3.0 All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
- 4.0 These instructions shall come into force with immediate effect and shall remain valid till further advice.
