Sub: Clarification regarding applicability of 8% discount on Base Freight Rate for Indented Parcel train to Bangladesh.

An extract of Railway Board's letter No.TC-II/2046/2020/15% discount P-Scale dated.16.02.2021 is reproduced below for information & necessary action:-

"In reference to the aforementioned subject, the matter has been deliberated upon in Board office. It has been decided that the 8 % discount on Base Freight-as per the FM circulars mentioned under ref-(iii) shall be applicable only on domestic traffic and not on export traffic to Bangladesh.

This issues in consultation with Finance Directorate of Ministry of Railway and with the approval of Competent Authority.

All concerned to please note and act accordingly.
