For formation of Group-B Panel of 01 (SC) post of AME/AWM against 30% LDCE quota vacancy for the assessment period from 01.04.2019 to 31.03.2021 in Mechanical Engineering Department/ECoR, notification was issued vide letter under reference (1). It has been decided by the competent authority that the pre-qualifying written examination for AME/AWM against 30% LDCE quota vacancy for the assessment period 2019-21 in Mechanical Engineering Department/ECoR will be held on **16.03.2021 (Tuesday) from 10.30 Hrs to 12.30 Hrs at the Mixed Higher Secondary School, East Coast Railway, Khurda Road.**

All the 34 eligible candidates should be informed accordingly and spared to report to the Presiding Officer of the examination centre at **09.30 Hrs on 16.03.2021 (Tuesday)** for the written test with their proper Identification Memo.

This notice is to be widely circulated amongst the eligible staff. In case any candidate is on leave/sick/deputation to other Railways or Units, the controlling officer(s) concerned should send necessary advice to the authority under whom he is working or medical authority as the case may be and acknowledgement obtained. The candidature of the candidates has been accepted provisionally. If any candidate is subsequently found ineligible at any stage of the selection, his candidature will be rejected without any further notice.

NB: As per extant rule, no supplementary examination is permissible in LDCE for the absentees.
