Sub. Revised Haulage Charges for postal traffic for 2019-20

- Ref: 1. Railway Board's Freight Marketing Circulars No. 24 of 2019 dated 12.09.2019  
2. Member (Operations) Postal Services Board's D.O. letter no. 3- 01/2012-D (Vol.II) dated 13.01.2020.

Instruction on Haulage charges for Postal traffic carried in postal vans and non-postal vans for the year 2019-20 has been revised through Freight Marketing Circular No. 24 of 2019 dated 12.09.2019. Based on the request from Department of Posts as referred above (ref2) the applicability of haulage charges for the year 2019-20 has been reviewed and it has been decided to revise the haulage charges for postal traffic carried in postal vans and non-postal vans for the years 2019-20 as under:-

Distance Slabs	2019-20
0-500 Km	₹0.96 per berth per Km.
501-1000 Km	₹0.61 per berth per Km subject to minimum realization of haulage charges applicable on distance of 500 Km. subject to minimum of ₹480/-.
1001 Km and above	₹0.51 per berth per Km subject to minimum realization of haulage charges applicable on distance of 1000 Km. subject to minimum of ₹610/-.

- Point to point charges shall be rounded off to the next multiple of five.
- Other terms and conditions mentioned in the letter dated 19.2.2007 and revised from time to time for charging of postal traffic, billing and payment will remain unchanged.
- This issues with the concurrence of the Finance Commercial Directorate of the Ministry of Railways.
- Necessary instructions may be issued to all concerned immediately.
