

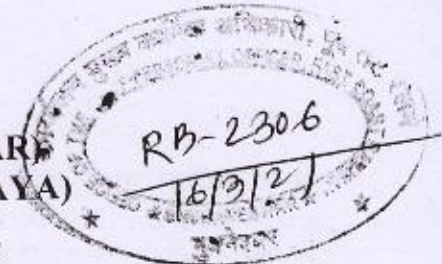

**Sub: Admissibility of Direct Recruited pay to the post of Principals in
Railways College /School in terms of MoF's O.M. dated 28.09.2018.**

Various representations have been received in this office seeking clarification regarding admissibility of DR pay to the incumbents of the posts of Principals working in Railway's Secondary Schools in terms of provisions contained in MoF's O.M. No. 8-23/2017-E.IIIA dated 28.09.2018 adopted on Indian Railways vide Board's letter No. PC-VI/2018/I/RSRP/1 dated 12.10.2018.

2. The issue has been examined in consultation with the Ministry of Finance and the Associate Finance/Railway Board. It is clarified that the benefits of DR pay under Board's letter No. PC-VI/2018/I/RSRP/1 dated 12.10.2018 is applicable only in case of those posts which have an element of direct recruitment. In the Recruitment Rules (RRs) of the post of Principals in Railway schools, it is laid down that the post is to be filled up by promotion failing which by transfer on deputation, and failing both by direct recruitment. It only appears under 'failing which' clause, which cannot be construed as an element of Direct Recruitment in RRs. It would, therefore, not be feasible to extend the benefit of entry pay to such employees arising out of the instructions issued vide Board's letter No. PC-VI/2018/I/RSRP/1 dated 12.10.2018 (RBE No.158/2018).
