

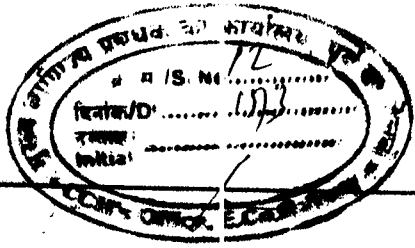

In supersession of DFCR/BD Circular under reference (2), by exercising the powers of Railway Administration, as delegated vide letter under reference (1), it has been decided to open the following stations of this Railway, to book and handle all traffic excluding Coal and coke under 'C' priority :

1.	New Makkhanpur	MNRN	17109041	Up Loop Line No. 1A	Full Rake Terminal
2.	New Daudkhan	DAQN	17109044	Up Loop Line No. 1 and 1A	Full Rake Terminal
3.	New Khurja	KRJN	17109045	Up Loop Line No. 1, Hot Axle Siding and ART Siding	Full Rake Terminal

It has been decided to use the loop lines/ station sidings mentioned against the name of above stations as Goods lines for loading/ unloading of Outward/ Inward goods traffic booked from/ to these stations. Commercial rules of Indian Railways will be applicable on DFCCIL mutatis mutandis like a zonal railway. Commercial activities at the above stations will be performed by Sr. Executive/ Executive (OP&BD) posted at these stations. All concerned to please note and take necessary action accordingly.
