In terms of Corrigendum No.20 & 27 superseded by Corrigendum No.28 to Rates Master Circular/2016 dated 14.07.2016 on Block Rakes/Mini Rake/Two Point Combination etc., Standard Rake Size, Minimum number of wagons to be loaded for BAFRDR wagon were notified w.e.f. 19.12.2019 till 21.09.2020 and further extended up to 31.03.2021 in terms of Corrigendum No.05 to Rates Master Circular on Block Rakes/Mini Rake/Two Point Combination etc./2020 as under:


