### Commercial Circular No.117(G)/2021

**Sub:** Exemption from payment of Stabling Charges for rakes procured under LWIS, SFTO & GPWIS Schemes.

**Ref:** Board's letter No.TC-I/2019/201/2 dated 27.03.2020, 14.04.2020, 25.04.2020 & 05.05.2020, circulated vide CCM/ECOR's Commercial Circular Nos.72(G)/2020 dated 27.03.2020, 81(G)/2020 dated 14.04.2020, 94(G)/2020 dated 27.04.2020 & 104(G)/2020 dated 06.05.2020 respectively.

Please refer to Railway Board's letters under reference vide which, inter-alia, rakes being operated under LWIS, SFTO & GPWIS Schemes were exempted from payment of Stabling Charges till 17.05.2020.

The matter has been examined and the competent authority has decided to extent the guidelines regarding non levy of Stabling Charges in case of rakes procured under LWIS, SFTO & GPWIS Schemes till 31.03.2021, post which normal guidelines will be applicable.

This issues in consultation with Rates and Traffic Transportation Directorates and with the concurrence of Finance Directorate of Ministry of Railways.
