Sub : Exemption from para-4 of Rule 125 of IRCA Goods Tariff

No.41,pt.I Vol.I for fertilizer traffic from dual gauge stations

Between Samakhiali and Gandhidham via Palanpur transshipment

Point : post facto sanction.

Post facto sanction of the Central Government is accorded to the relaxation of Rule 125(4) of IRCA Goods Tariff No.41,pt.I Vol.I in respect of fertilizer traffic booked from dual gauge stations between Samakhiali and Gandhidham (including siding and Kandla Port) and moved via MG-BG route via Palanpur transshipment point between 30.9.1997 and 31.10.1998 . The fertilizer traffic moved via Palanpur transshipment in the above period would be charged by the actual MG cum BG route without comparing with the all BG route.
