Sub: Supplying of VPU/VPH Specials for Mango Loading

A number of representations have been received from different parties asking for movement of mango traffic in train loads from Vizianagaram to Naya Azadpur during the ensuing mango season (April 2004 to June 2004). In view of limited availability of VP/VPU/VPHs, Board has decided that 4 VP/VPU/VPHs rakes each consisting of 20 VP/VPU/VPHs will be deployed in the close circuit between Vizianagaram and Naya Azadpur. The balance demand will have to be met by deploying BCN/BCX rakes. Indents may be accepted as per extant rules in train loads of VP/VPU/VPH/BCN/BCXs at Vizianagaram from all parties. Ensure compliance accordingly and confirm.
