SUB : Trainload benefit – Piecemeal indents .

Some Railways have sought clarification regarding grant of trainload benefit to piecemeal indents of different consignors registered on different dates clubbed to form a rake for operational convenience .

It is clarified that in terms of paras 2.1(a) and 2.4 of Board's policy circular No. TCR/1017/91/2 dated 17.8.98 circulated by S. E. Railway vide special circular No. RA.41/Rates/1A/G/Pt.V/cont.2 dt.7.9.98 [SL. No. 73 (G) / 98 ] , benefit of trainload rate can only be granted when the consignor (s) indents for standard rake size , though for more than one commodity booked in the same rake .

The instructions in the matter may please be reiterated to the concerned staff .
