Refer to Board's letter of even No. dt.07.04.2004 and 28.05.2004 wherein the revised procedure to be adopted for arriving at chargeable distance was communicated as effective from 01.06.2004 and 01.07.2004 respectively. As Zonal Railways have expressed inability to switch over to the revised procedure from 01.07.2004, Rly. Bd. have issued instructions that the revised procedure of charging fares and freight by rounding off the actual engineering distance only once at the end, shall come in to force from 01.10.2004 (First October Two thousand four).
