In terms of Rates Circular No.06 of 2019, the permission for operation of container trains by Private Container Operator (PCO) in railway owned terminals notified as Container Rail Terminal (CRT) is valid upto 31.03.2021.

The matter has been reviewed and it has been decided to extend the currency of extant instructions regarding operation of container trains by Private Container Operators (PCO) in railway owned terminals notified as Container Rail Terminal (CRT) beyond 31.03.2021 for a further period of six months i.e. upto 30.09.2021.

This issues in consultation with Traffic Transportation Dte. and with the concurrence of Finance Dte. of Ministry of Railways.


