
The result of the Pre-qualifying written examination held on 16.03.2021 for formation of Group-B/Mechanical Panel of 01 (SC) post of AME/AWM for the assessment period 2019-21 against 30% LDCE quota in Mechanical Engineering Department of ECoR and the readiness notice for the Main Examination was published vide this office letter under reference, declaring seven candidates qualified for the main written examination.

In terms of Railway Board's letter No. E(GP)2018/2/31 dated 19.03.2019 (RBE No.53/2019), candidates securing 75% marks and above in the Pre-qualifying examination shall be eligible for appearing in the main examination and for this, number of candidates should be restricted to 5 times the number of respective vacancies in order of merit.


