It is hereby intimated for all concerned that , the rules hereby called the Railways ( Punitive charges for over loading of wagons) rules, 2004 ,shall come into force **from** date of their publication i.e. 18.10.2004 .

The undercharges if any in respect of inward traffic should be calculated & realised from the party concerned & similarly under charges calculated on outward traffic may be billed and sent to the destination for collection .
