Sub: Minimum Composition of 'Indented' Parcel Trains.

Ref: Railway Board's letter No. 2020/TC(FM)/11/11 dated 22.06.2020 and No. 2020/TC(FM)/11/11-Pt.1 dated 18.08.2020 (This Office CC No. 135(GC)/Parcel/2020 Dt.22.06.20 & CC No. 198(GC)/Parcel/2020 Dated 24.08.2020).

Extract of the Railway Board's letter No. 2020/TC(FM)/11/11/Pt-1 dated 29.05.2021 is reproduced below for information and necessary action Please.

"Please refer to this office's letter under reference, wherein instructions are issued regarding reduced minimum composition of "Indented" parcel trains, which were valid till 31.03.2021.

The matter has been reviewed and in view of the second wave of COVID-19 pandemic throughout the country, Competent Authority has decided that the minimum composition of "Indented" parcel trains shall be "**10 Parcel Vans + SLR**" for perishable traffic and "**15 Parcel Vans + SLR**" for other traffic. These instructions shall remain in force till 30th September 2021.

The existing instructions regarding minimum composition of Indented Parcel trains comprising of GS Coaches shall remain applicable without any change.

These instructions shall be applicable with immediate effect. Zonal Railways may take necessary action accordingly".

All concerned to note and act accordingly.
