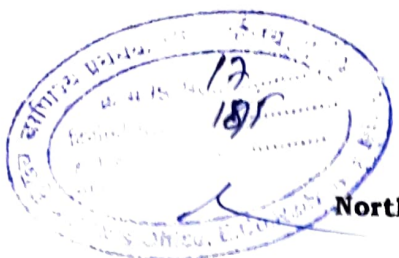

Restriction on booking of parcel & Luggage (Including leased traffic) at HW,RKSH, YNRK,LRJ,RK,&NDB stations over Moradabad Division was imposed vide this notification no. 26/2021 dated 08/04/21 due to Kumbh Mela 2021 up to 30.04.2021.

Due to increasing in COVID-19 cases most of the AKHADAs have announced only bare minimum participation in the remaining period of Kumbh Mela. To maintain supply chain of essential goods DRM/MB is recommended to lift restrictions with immediate effect.
