Sub:- All India Engine Hour Cost (AIEHC) for recovery of Siding and Shunting charges.  
Ref:- Board's letter No. TC-I/2002/214/5 dated 17.06.2020 (Rates Circular No.13 of 2020).

Ministry of Railways have decided to revise the All India Engine Hour Cost circulated vide Board's above mentioned letter [Circulated vide Commercial Circular No.132(G)/2020 {letter No. PCCM/Sdg/AIEHC/Pt.-I dated 18.06.2020}] for recovery of Siding and Shunting Charges. The revised rates will be effective from 01.08.2021 as under:

### 2.0 Revised Rates

- 3.0 Costs to be recovered for steam locos wherever in use over Indian Railways shall be identical to that of Diesel Engines indicated above.
- 4.0 These revised costs will remain in force until further orders.
- 5.0 Rounding off of shunting period would continue to be done as per instructions laid down in Para 3.6 of Board's letter No.TC-I/2008/214/1 dated 06.02.2009 (Rates Circular No. 14 of 2009) and as amended from time to time.
- 6.0 Action may please be taken to give due notice to the siding owners before introduction of revised Siding and Shunting Charges.
- 7.0 The afore-mentioned instructions will also be applicable for Indo-Nepal Traffic.
- 8.0 This issues with the concurrence of Finance Directorate of Ministry of Railway.

All concerned are requested to note and act accordingly.
