Sub: Routes of running of 25 Tonne Axle load wagons.

- 1.0 In terms of reference at (i) & (ii) above, Board's approval communicated for restarting of 25 Tonne axle load operation with such rolling stock as are fit / certified for 25 Tonne axle load on various notified routes.
- 2.0 The routes are notified in terms of Annexure-IV of reference (iii) above.
- 3.0 Matter has been reviewed and the Competent Authority have approved to add following route in the list attached as Annexure-IV of Rates Master Circular under reference (iii) above, as 25 Tonne axle load notified routes:
